

Terms and Conditions

1. Detailed description of goods and/or services

St Alban's College Foundation is a non-profit organisation in the Education industry that supports St Alban's College through scholarships, bursaries, donations to capital projects and legacy capital.

2. Delivery policy

Subject to receipt of payment, donations will be processed within 7 working days and receipt of such payment will be emailed to the donor together with the relevant supporting documentation such as a Tax Certificate issued in terms of Section 18A of the Income Tax Act.

3. Return and Refunds policy

All donations made to the St Alban's College Foundation are non-refundable once the funds have cleared into the Foundation's bank account.

4. Customer Privacy policy

St Alban's College Foundation shall take all reasonable steps to protect the personal information of users. For the purpose of this clause, "personal information" shall be defined as detailed in the Promotion of Access to Information Act 2 of 2000 (PAIA). 5. Payment options accepted

Payment may be made via Visa, MasterCard, Diners or American Express Cards or by bank transfer into the St Alban's College Foundation bank account, the banking details of which will be provided on request.

6. Card acquiring and security

Card transactions will be acquired for The St Alban's College Foundation via PayGate (Pty) Ltd who are the approved payment gateway for all South African Acquiring Banks. DPO PayGate uses the strictest form of encryption, namely Secure Socket Layer 3 (SSL3) and no Card details are stored on the website. Users may go to www.paygate.co.za to view their security certificate and security policy.

7. Customer details separate from card details

Customer details will be stored by the St Alban's College Foundation separately from card details which are entered by the client on DPO PayGate's secure site. For more detail on DPO PayGate refer to www.paygate.co.za.

8. Merchant Outlet country and transaction currency

The merchant outlet country at the time of presenting payment options to the cardholder is South Africa. Transaction currency is South African Rand (ZAR).
